

Privacy Policy

This Privacy Policy ("Policy") applies to policeofc.com, and UNITED STATES LAW ENFORCEMENT LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include policeofc.com and Police Officer. The Company's website is a news and e-commerce site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

-First and last name -Mailing address -Email address -Phone number -Employer -Job title

If you purchase the Company's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

The Company may also collect anonymous demographic information, which is not unique to you, such as your:

Sharing Information with Third Parties
